## message from the chair

I am privileged to be able to introduce this year's annual review, my first as the Chair of Nhimbe Trust, which sets out our many groundbreaking achievements in what has been an exciting and vibrant year.

As we celebrate the 10th anniversary of
Nhimbe Trust, we feel justly proud to have been
the game changer by organising the first
seminar between creative civil society and the
Parliamentary Committee on Education, Sport,
Arts and Culture since Zimbabwe's independence
in 1980! Another game changer was the establishment
of the Zimbabwe Festivals Network at a festival managers'
seminar hosted by Nhimbe with support from the National
Arts Council and with funding from the UNESCO. Further, support
was received from Africalia towards Zimbabwe Festivals Network secretariat
being hosted by the Protest Arts International Festival, which is hosted by Savanna Trust.

The board had the privilege to attend the WiT-Labs Festivals Symposium and performances by the Schools Playwrights and Actors Academy (SPAA) and the Women in Theatre (WiT) - Labs during Intwasa Arts Festival koBulawayo. We are grateful to Africalia for its support, and also for being the main funding partner for Nhimbe over the years. I would like to express our gratitude to the outgoing board chair, Dr Tsitsi Choruma and to outgoing trustees, Okay Machisa and Dr Lawton Hikwa, who have helped establish such a positive context for cooperation and positive collaboration.

We commend the Executive Director Josh Nyapimbi for mobilizing additional partnerships, in particular the Culture Cluster of the Commonwealth Committee, which offered to help upgrade capacity and professionalism from which Nhimbe Trust will benefit.

At the September board meeting, we identified the need and set the tone to begin the process to review and refresh the organisation's strategic focus from 2014-2018. This review is being largely informed by a SWOT analysis and reasonable assumptions on the country's social, economic and political realities for the next five years, being the term of office for the new government and parliament. Further, the refreshed strategy will also articulate innovative and exciting lessons from the Commonwealth fellowship received. Some have started being implemented and show promising results.

Over the next few pages of this Annual Report, the Executive Director chronicles the work done by Nhimbe during the year. I would like to thank the staff for the hard work over the year with limited funding and in an unfavourable economic and political environment. ## SCHOOLS' PLAYWRIGHTS AND ACTORS ACADEMY

Providing the opportunity for students to work directly with professional actors, writers, directors and producers is core to the SPAA and WiT-Labs ethos



In 2013 the SPAA class had an enrolment of 35 students (17/18) in favour of boys. SPAA produced two plays. Jazi explores and challenges stigma and discrimination for adolescents in accessing sexual and reproductive health services, especially access to condoms. Kolobeja is an interactive folk tale play of stories from a Zimbabwean Childhood. SPAA performed at selected schools across Bulawayo, Bulawayo Theatre and Intwasa Festival. The SPAA was established in 2009 to provide talented high school students with professional training, mentoring and resources to produce and perform plays based on themes pertinent to their social and educational endeavours. The SPAA weekend class is run every Saturday at Nhimbe. Students enrolled at SPAA are competitively auditioned across Bulawayo from a pool of about 60 high schools.

As one student puts it, SPAA enables 'that step up' from student to professional artist to him who wishes to make a profession in the theatre.

WiT-Labs, in partnership with Amakhosi Plays on Sunday, conducted six master classes in writing and directing for 20 women in theatre from Bulawayo. WiT-Labs performed their play, Song of a Woman, before capacity audiences at Bulawayo Theatre during Intwasa Festival and at the National Gallery in Bulawayo in commemoration of the 16 Days of Activism against Gender-based Violence. Song of a Woman is a workshop production directed by Thembelihle Moyo and produced by Nonhlalo Dube. During Intwasa, WiT-Labs also hosted a day-long symposium on how local festivals programmed women in theatre. The HIFA executive director Maria Wilson gave a case-study on the Harare International Festival of the Arts – HIFA. Please refer to page 8 for a table of statistics on HIFA's programming for women in theatre from 2009 to 2013. The WiT-Labs Festivals Symposium was attended by 20 women theatre writers, directors, actresses and set designers. Also in attendance were Olga Muhwati and Tambudzai Madzimure from the Culture Fund of Zimbabwe Trust and Hivos respectively.

Courses with the University of Nottingham as part of an international law programme. He has worked in the human rights and democracy field in various roles since 2005. Initially in the Ministry of Justice, Legal and Parliamentary Affairs as part of the secretariat for the Interministerial Committee on Human Rights and International Humanitarian Law, Brian left the government in 2006 to join the Zimbabwe Human Rights NGO Forum, where he worked progressively in different capacities until he was eventually appointed Programmes Coordinator for the Forum in 2008. The creative civil society in Zimbabwe welcomes the constitutional court's ruling on 29 October 2013, which found provisions of the Criminal Law (Codification and Reform) Act to be unconstitutional. This development, which confirms the long-held view by artistic freedom and human rights defenders that the laws governing freedom of creative expression in Zimbabwe were repressive and a violation of fundamental civil liberties due to citizens in general and artists in particular, as provided for by the constitution and regional instruments on freedom of expression. The judgment, which has come as the African Commission on Human and

People's Rights Special Rapporteur on Freedom of Expression, Pansy Tlakula, is pushing for decriminalisation of free expression on the African continent, creates a strong legal precedence against which the democratisation of freedom of expression laws can be anchored.

As it relates to freedom of creative expression, the ruling followed a constitutional challenge by Owen Maseko v AG. Maseko was charged under Section 31(a)(i) and Section 33(a)(ii) of the Criminal Law (Codification and Reform) Act. Section 31(a)(i) criminalises the inciting or promotion of public disorder or public violence or endangering public safety, while Section 33(a)(ii) makes it a criminal offence to 'cause hatred, contempt, or ridicule of the President or Acting President, whether in person or in respect of the President's Office.' Maseko's charges stemmed from his exhibition of his work on the Gukurahundi episode. The constitutional court found the above mentioned provisions to be inconsistent with the constitution and called on the Minister of Justice, Legal and Parliamentary Affairs to present himself before the same court on November 20, 2013 to show cause why the provisions should not be struck off the country's statutes.

It is creative civil society's hope that the minister will readily concur with the observations of the court, thereby allowing for the liberalisation of the creative space and the full exercise of artists' right to freedom of creative expression.

The International Culture University Campus in Zimbabwe (ICUZ), hosted by Nhimbe in partnership with NPAAC, launched a Fellowship Programme, which seeks to nurture a new generation of local cultural policy experts and to strengthen their expertise in cultural policy discourse, advocacy and lobbying. The are three inaugural fellows. Mcgini Nyoni published the first ICUZ Journal and is currently working on the second edition. Mcgini also hosted the creative civil society 2014 national budget consultation seminar. Nonhlalo Dube is a fellow on Women in Theatre and Festivals. She hosted the inaugural WiT-Labs and Festivals Symposium. The third and final Fellow is Butshilo Nleya, whose fellowship is on Cultural Mapping and the Creative Economies for cities, with a primary focus on the city of Bulawayo.


